

Association

Dues (billed in **September**; due and payable within 30 days):

- **Accredited and Candidate Colleges:** Annual dues of \$2,000
- **Branch Campus Fee:** Each accredited branch campus is assessed according to the following schedule:

0-249 HDCT	\$250
250-499 HDCT	\$500
500-749 HDCT	\$750
750 or more HDCT	\$1,000
- **Applicant Colleges:** Annual dues of \$1,800
- **Accredited Programs:** Base dues of \$1,200 for the first program accredited and \$100 for each additional program accredited; total dues not to exceed \$1,500
- **Affiliate Institutions**
 - **Affiliate application processing fee:** \$100, non-refundable; required with submission of Affiliate application to the Association office; applicable to first-year annual Affiliate dues
 - **Annual Dues:** \$750 includes one free delegate registration per Affiliate institution to the ABHE Annual Meeting (\$285 value).

Commission on Accreditation

Dues (billed in **March**; due and payable within 30 days):

- **Accredited, Candidate, Applicant Institutions:**
 - Variable rate of \$6.50 multiplied by total Fall 2008 institutional Headcount (HDCT) enrollment.
Note: Total FY Association and Commission on Accreditation dues assessment will not exceed \$5,000.

Evaluation Fees (invoice accompanies consultation report; due and payable within 30 days):

- **Candidate Status, Initial Accreditation, Reaffirmation Team Visit (4-7 persons):**
 - Evaluation team fee of \$3,500, plus evaluator travel expenses.
- **Joint/Coordinated Visit Evaluation Team Visit (2-3 persons):**
 - Evaluation team fee of \$2,000, plus evaluator travel.
- **Special Purpose Visit [e.g., branch campus, merger] (2-3 persons):**
 - Evaluation team fee of \$2,000, plus evaluator travel.

Consultation Fees (invoice accompanies consultation report; due and payable within 30 days):

- **Pre-Applicant Consultation Visit:**
 - Fee of \$1,200, plus consultant travel expenses for a 1-day visit by a senior Commission staff consultant for the purpose of orienting key stakeholders to the ABHE accreditation process, inventorying compliance with ABHE *Conditions of Eligibility*, and advising the institution concerning submission of a petition for Applicant Status.
- **Initial Consultation Visit:**
 - Fee of \$1,600, plus consultant travel expenses, for a two-day visit by a senior Commission staff consultant following the granting of Applicant Status.
- **Commission Staff Consultation Visit:**
 - For all Commission staff visits other than the initial consultation visit, \$1,200 for first day and \$600 per subsequent day, plus consultant travel expenses.

Application Fee

- \$2,000, non-refundable (Required with submission of Application to Commission office; no application will be processed prior to application fee payment.)

Termination of Status

- The Commission on Accreditation may terminate Accredited, Candidate, or Applicant members for failure to pay membership dues or fees upon receipt of invoice. In extenuating circumstances, a grace period of up to six months may be requested in writing.
